The Planning System and Neighbourhood Planning: FAQs

The attached "Locality" toolkit answers the most common questions asked by those not familiar with the planning system. It helps explain how the planning system operates, where neighbourhood planning fits in, and the neighbourhood planning process itself.

Neighbourhood Plans Fail to Support Government Ambitions

Neighbourhood plans not supporting government ambitions to meet the housing need, with fewer than half containing allocations for new housing in their communities, according to new research. "*Local Choices? Housing Delivery Through Neighbourhood Plans*" finds that 40 per cent of the 330 neighbourhood plans considered contain allocations for new housing, with half of these new allocations.

Matthew Spry, senior director and head of economics at Lichfields, who conducted the research, said: "*Our research shows 60 per cent of plans do not contain a housing figure or site allocations, which suggest that local communities are placing greater emphasis on other planning issues such as the protection of local infrastructure, services and green spaces.*"

According to the planning consultancy, the lack of housing allocations is in part down to the "tardiness" of the local planning system, with "less than half" of local authorities outside London having local plans in place. Spry said neighbourhoods are delivering housing growth at the local level, thanks to "*positively prepared strategic local plans*", something the government is focused on ensuring are in place. "*Even then, neighbourhoods would have to vote for higher growth. It is only in those instances where Neighbourhood Plans can be said – with certainty – to be seeking to deliver additional homes.*"

The research suggests that since the 2011 Localism Act, which provided for neighbourhood plans, only 15 of the 330 plans reviewed opted for more housing than a corresponding local plan. It also notes that neighbourhood plans are primarily located in the South East, the West Midlands and the East Midlands. Although 55 per cent of neighbourhood plans are coming forward ahead of local plans, Lichfields said up-to-date local plans with clear housing targets are the key to delivering growth.

"In the absence of a housing requirement, local communities may choose not to allocate sites for development due to local community priorities or lack of community appetite,"

Spry explained. *“This will impair a council’s ability to boost the supply of housing. Those neighbourhood plan areas with robust housing allocations are those following the stipulations of a local plan. This continues to highlight the importance of local plans setting the strategic policies for areas.”*

Members asked that the Clerk get more information on this subject.

131/18. To discuss re using the artificial trees or purchase real trees

Some of the trees were damaged when taken down, they have separated from the base of the stand due to wear and tear. Approximately 20 are damaged and would need to be replaced. Cost circa £5 per tree.

If real Christmas trees were to be purchased costs would be circa £10 per tree and we would need to purchase 70.

It was agreed that the Clerk order them as soon as possible.

(2) Email from Hayley Cooper SSDC

“Good Afternoon,

I would like to introduce myself as the Business Engagement Officer at South Staffordshire Council, I work closely with local businesses within the district in many ways. One of which is helping South Staffordshire become a Dementia Friendly Community. In order to do this we run small workshops within local businesses, community centres, libraries, and parish meetings that educate people on how to help and assist people living with Dementia. I would like if possible to arrange a date for our Dementia Friend to come and spend an hour with some of your colleagues and community members to show them how small differences can really enhance people’s lives. Once completed the individual will gain the accreditation of becoming a dementia friend and will receive a Dementia Friend badge, this will then demonstrate to the public that your organisation has gone through training and is a safe place for people living with Dementia to go.

(3) Footpath at Comber Ridge

A lady has complained about the slope going from the lower car park to the Turning Circle at Comber Ridge.

The Clerk has looked into options to make the path easier to walk up;

Steps would not work as the slope is too long and also difficult to get a coffin trolley up it...

Handrail, could be fitted to help with support if required cost circa £200.

Remove stones and lay a grid underneath, then relay stones on top to make it less slippery to walk on, cost circa £681, this is just for materials, there would be labour costs and plant hiring machines also.

She has only received one complaint about the path and at a recent funeral many mourners walked up the path without issue...

As this is a natural hillside burial site, access improvements are limited due to the lay of the land, members thanked the Clerk for bringing this to their attention but felt that there is nothing further that can be done to change the access paths.

The Clerk has made the offer available, that when they wish to visit the site she will ensure the gates are open for them to drive in and park as close as possible to their grave side to limit the walking from the car.

(d) Gothersley Lock

The Clerk has received the email below from Helen Marshall:-

“Good afternoon all,

ITEM 132/18 RESTORATION OF STERRYMERE LAKE

In January 2013 SSDC gave planning permission for the restoration on Sterrymere Lake. Later that year a material start was made, which was accepted by SSDC, and so the permission was "in perpetuity". However it was only possible to raise about half the budgeted £200K for the project so it was abandoned.

However an opportunity has now arisen for the project to be completed .

Recently ,Richborough Estates held an open day outlining their proposals to develop land at Hyde lane, in line with this being identified as one of the two prime areas for Kinver to build housing and satisfy its commitments

Importantly, the plan proposes an area for "Surface Water Attenuation "

However members of Friends of Kinver Open Spaces (FOKOS) observed that the Developer was unaware that planning had already for the Sterrymere project further downstream. This project would do exactly the same job as what they were proposing with their "Surface Water Attenuation" plan. But the Sterrymere Plan would have several plus factors

1) Whilst realising their necessary objective in satisfying Flood Plain considerations, they would be able to provide the village as a whole with a very desirable amenity of a lake, where there is currently a dried up river bed.

2) They would be avoiding the regular flooding of the KCSA playing fields which occur via the Mill Brook coursing through the spinney at the back of the playing fields rather than along a redefined river course into a lake.

3) The land which would otherwise be used as a soakaway would then become available for further development. Whether that be for a public amenity, or even future housing.

4) This would save developer negotiation re water retention in their development plans, and costs

FKOS and members of KSCA have asked me to make the Parish Council and our District Cllrs. aware of this opportunity as the development plans/project progresses. As you are aware I was Chairman of FKOS for its first 5 years and was involved in the develop of the Sterrymere scheme
